"I couldn't let thousands of people whom I had come to depend upon die." Chiune Sugihara, often called Japan's Schindler, saved the lives of 6000 Jews by issuing transit visas from them. The descendants of those who survived because of his actions now number in the tens of thousands, and messages of gratitude continue to pour in from across the world. When looking to receive *anma* massages, *shiatsu*, acupuncture or moxibustion, please confirm that your treatment will come from a licensed practitioner. - **Applicable Tax and Taxation Period:**

【Corporate Enterprise Tax】 Each fiscal year which ends between April 1th, 2016 and March 31st, 2020

【Individual Enterprise Tax】 Tax applies on income from the 2016 to 2019 fiscal year
