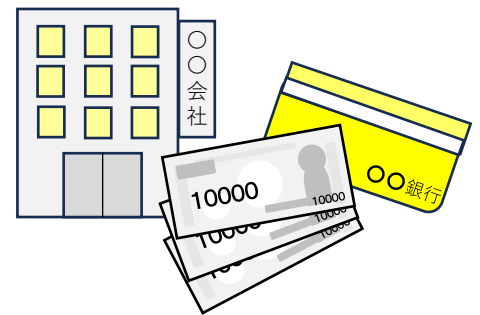

The automobile tax is not to be paid when you renew your vehicle inspection certificate.
If payment is not made by the deadline and there is no requested consultation on tax payment, seizure of property will be carried out in accordance with the provisions of the law.

Regarding collection of taxes in arrears (seizure)

In addition to investigating your workplace, bank accounts, and business partners, and seizing your wages and savings, we may take measures to lock the tires of your car to make it impossible to drive.

Seized cars will be sold at public auctions on the Internet.

Payment method, etc.

① From a smartphone payment app

By using a smartphone app and reading the QR code printed on the payment slip with the smartphone's camera, the payment can be made from the pre-charged balance. For information on available payment apps, please visit the "eL Payment Site" and see the "List of Smartphone Payment Apps."

② From the local tax payment website

You can pay your taxes by visiting the Local Tax Payment Website from your computer or smartphone and using a credit card, internet banking, or Pay-easy.

③ From financial institutions, post offices, convenience stores, etc.

Please present your payment slip at the counter and make your payment. After September 11, payments will not be possible at convenience stores, etc.

Late fees

The late fees shown on the payment slip are as of August 30, 2026. Even if the payment is made within the specified deadline, there may be an insufficient amount of late fees depending on the date of payment. If there is a difference between the late fee stated on the invoice and the amount due on the payment date, please pay using the invoice that we will send to you at a later date.
